#### \* INSTALLMENT PAYMENTS\*

The Board of Education has adopted an installment plan for school taxes. Taxpayers may pay the following installments: 50% of the total amount due by September 30<sup>th</sup> with no interest; 25% of the total amount due by October 31<sup>st</sup> with 2% interest; and 25% of the total amount due by November 10<sup>th</sup> with 3% interest. Payments made after the due date without the correct interest will be returned.

- ✓ Navigate to Sullivan County;
- ✓ In the third column, under "School Districts" click on "Fallsburg;"
- ✓ Search for your parcel by: property address, owner's last name, tax map number, or bill number;
- ✓ Click on "Make A Payment" at the bottom of the screen and follow the instructions
- ✓ A 2.65% or \$3.00 minimum service charge for credit cards and \$1.50 for eChecks transaction charge will be added to each payment

#### TO PAY BY MAIL:

- ✓ Enclose tax bill STUB with your payment in the enclosed envelope;
- ✓ Include BILL NUMBER (top right corner of tax bill) on your check;
- ✓ Please make checks payable to: **SCHOOL TAX COLLECTOR**;
- ✓ Payment MUST BE POSTMARKED BY THE DEADLINE to avoid additional penalty.

It is not necessary to return the entire bill to receive a receipt; return only the payment stub with your payment. A receipt will be sent automatically in 30 days after payment processing and is subject to collection. This receipt is for your records and does not require payment.

Payments must be post marked by <u>September 30, 2023</u> to be accepted without penalties. Payments postmarked by <u>October 31, 2023</u> must include <u>2%</u> interest. Payments postmarked by <u>November 10, 2023</u>, the final day of collection, must include <u>3%</u> interest.

# NOVEMBER 10, 2023 IS THE LAST DAY TO PAY SCHOOL TAXES.

After November 10, 2023 unpaid school taxes will be re-levied with 7% compounded penalty on the January 2024 Town & County tax bills.

#### **STAR PROGRAM**
