# **Sign-up Guide for Non-filers**

July 7, 2021

This guide is meant to help you successfully complete the Non-filer Sign-up Tool to get Child Tax Credit (CTC) payments, as well as any Economic Impact Payments (EIP) — also known as stimulus payments — that you may have missed.\*

## Who should use the Non-filer Sign-up Tool?

People who:

- Had gross income at or below \$12,200 (\$24,400 for married couples) for 2020
- Lived in a U.S. state, the District of Columbia, or a U.S. military base for most of 2020
- Did not file a tax return for 2020
- Do not plan to file a tax return for 2020
- Were otherwise not required to file a federal income tax return for 2020
- Cannot be claimed as a dependent on someone else's tax return

## Before you start

You'll need the information below when you fill out this form. Please have it ready before you start:

- Social Security Number or Individual Taxpayer Identification Number (ITIN) for you and your spouse (if you have one)
- Social Security Numbers for your children
- A reliable mailing address
- An e-mail address
- Your bank account information (if you want your payments sent straight to your bank account by direct deposit)

You will not need a 1099 or W-2 to sign up.

If the Internal Revenue Service (IRS) sent you an Identity Protection Personal Identification Number (IP PIN) in the past, you'll need it to use this tool. If you lost it, use the [Get an IP PIN](#)\*\* tool to get your number back.

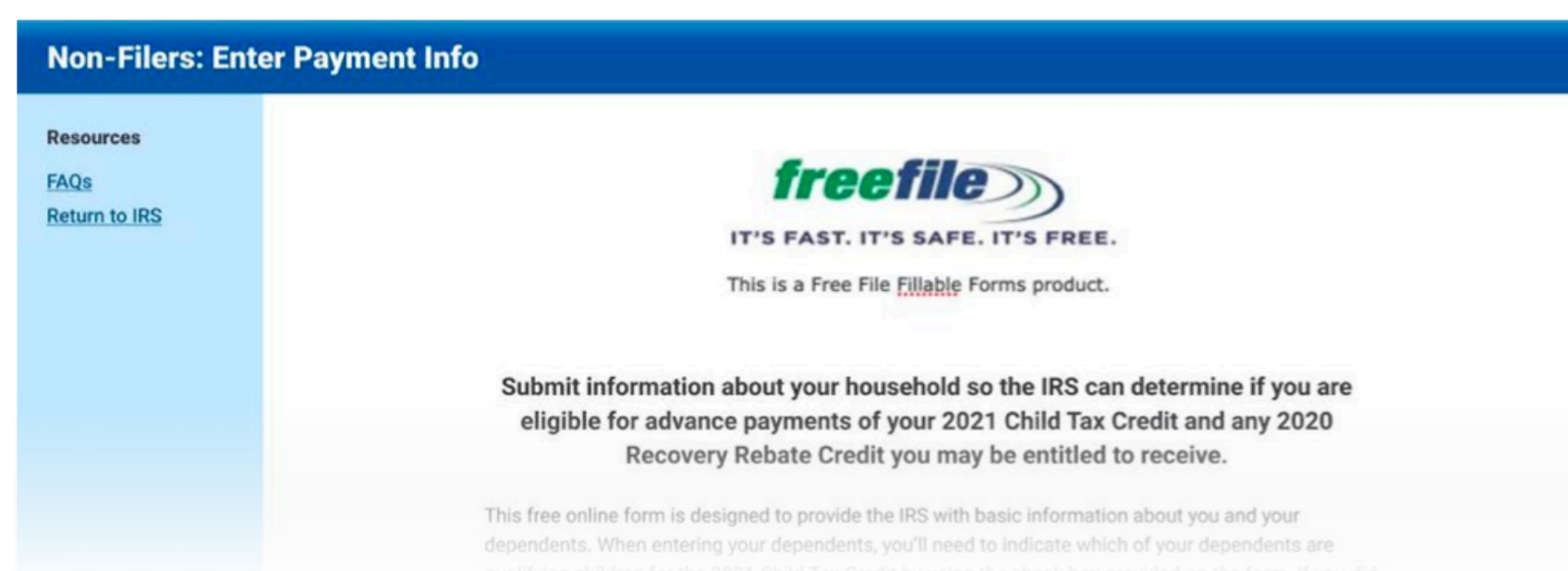
-  If you were married at the end of 2020, you and your spouse should only fill out the form in this Non-filer Sign-up Tool once together.

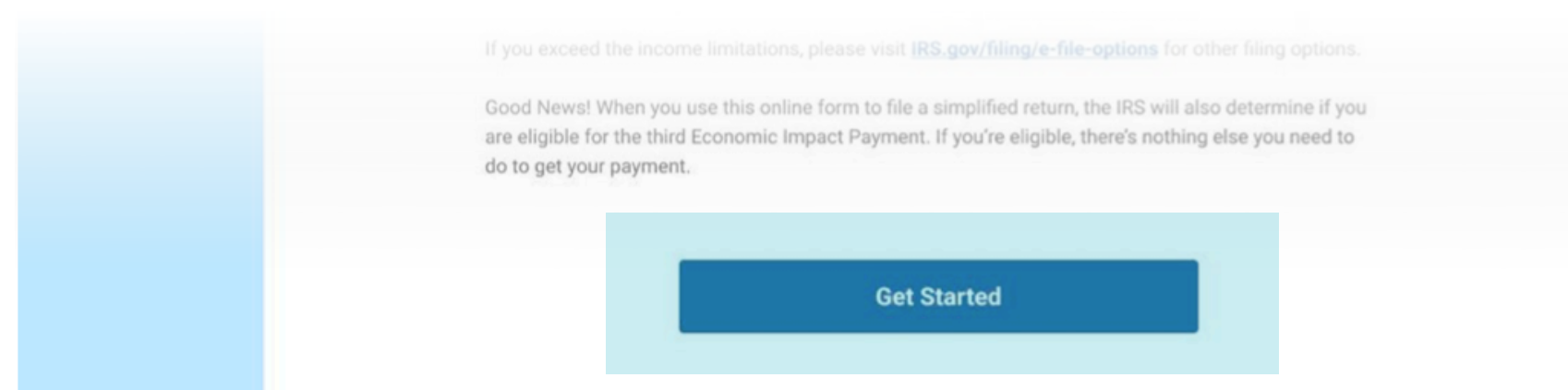

## Step 1: Fill out your tax forms

Filling out this simplified tax return will help you get 2021 Child Tax Credit (CTC) payments.

The Child Tax Credit (CTC) does not count as income for any family, so you won't lose your other government benefits by signing up for CTC payments. They do not affect your eligibility for other federal benefits like SNAP and WIC.

## Standard Deduction

Did someone else list you or your spouse as a “dependent” on their tax return in 2020? This means they listed you as a qualifying child or relative for tax savings or payments. If they did, select **You as a dependent** or **Your spouse as a dependent**. If no one listed you as a “dependent”, leave this area blank.

**ATTENTION:**

Stop if your gross income exceeds \$12,400 (\$24,000 for a married couple) or if you chose either radio button above, indicating you or your spouse, if married filing jointly, can be claimed as a dependent on someone else's return. You are not eligible to use this online form.

### Not sure if they qualify?

Check out this checklist. Each child must meet all of these requirements in order to qualify for the Child Tax Credit (CTC). If they do, great! Simply check the box under **Qualifies for CTC** on the same line as their name.

- The child is your son, daughter, stepchild, eligible foster child, brother, sister, stepbrother, stepsister, half-brother, half-sister, or a descendant of any of them (for example, your grandchild, niece, or nephew).
- The child was under age 17 at the end of 2020.
- The child did not provide over half of his or her own support for 2020.
- The child lived with you for more than half of 2020.
- The child can be claimed as a dependent on your return.
- The child does not file a joint return for the year (or files it only to claim a refund of withheld income tax or estimated tax paid).
- The child was U.S. citizen, U.S. national, or U.S. resident alien.


Next, you choose how you want to get your payments. Choose what works best for you: A) bank account, B) existing prepaid debit card, or C) mail.

### A) Get payments in a bank account

You can get payments sent straight to a bank account. These account payments are digital.

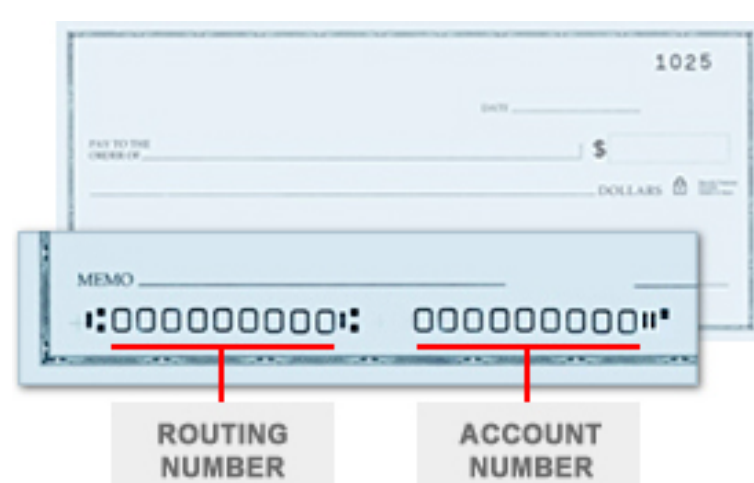


The account number is second. Please write your numbers carefully. Every account has different numbers, and the IRS wants to get payments to the correct person.



## B) Get payments sent to your existing prepaid debit card





## Identity Protection PIN

**Personal Verification**

You must enter either your 2019 Adjusted Gross Income (AGI), or your 2019 five-digit self-selected signature PIN. If you are filing a joint return, both taxpayers must follow this process.

A. Look at last year's federal tax return and enter your AGI in the space provided below. Look for your AGI on line 7 of the Form 1040.

### Enter Your Information

The form asks about last year's filing status. What this means is: did you file a tax return in 2020 to report on what happened in 2019?

- If you didn't file a tax return in 2020, enter "0" (zero) for the AGI in the **Your Information** and/or **Spouse's Information** boxes.
- If you used the Non-filer Sign-up Tool to claim stimulus checks in 2020, enter "1" (one) for the AGI in the **Your Information** and/or **Spouse's Information** boxes.
- If you did file a tax return in 2020, enter last year's AGI (line 8B on your 1040 form for 2019) in the **Your Information** and/or **Spouse's Information** boxes.

- If your spouse did not file a return last year, enter zero in the "Spouse" AGI space.  
- If you don't have or can't remember last year's AGI, use the IRS [Get Transcript Link](#)

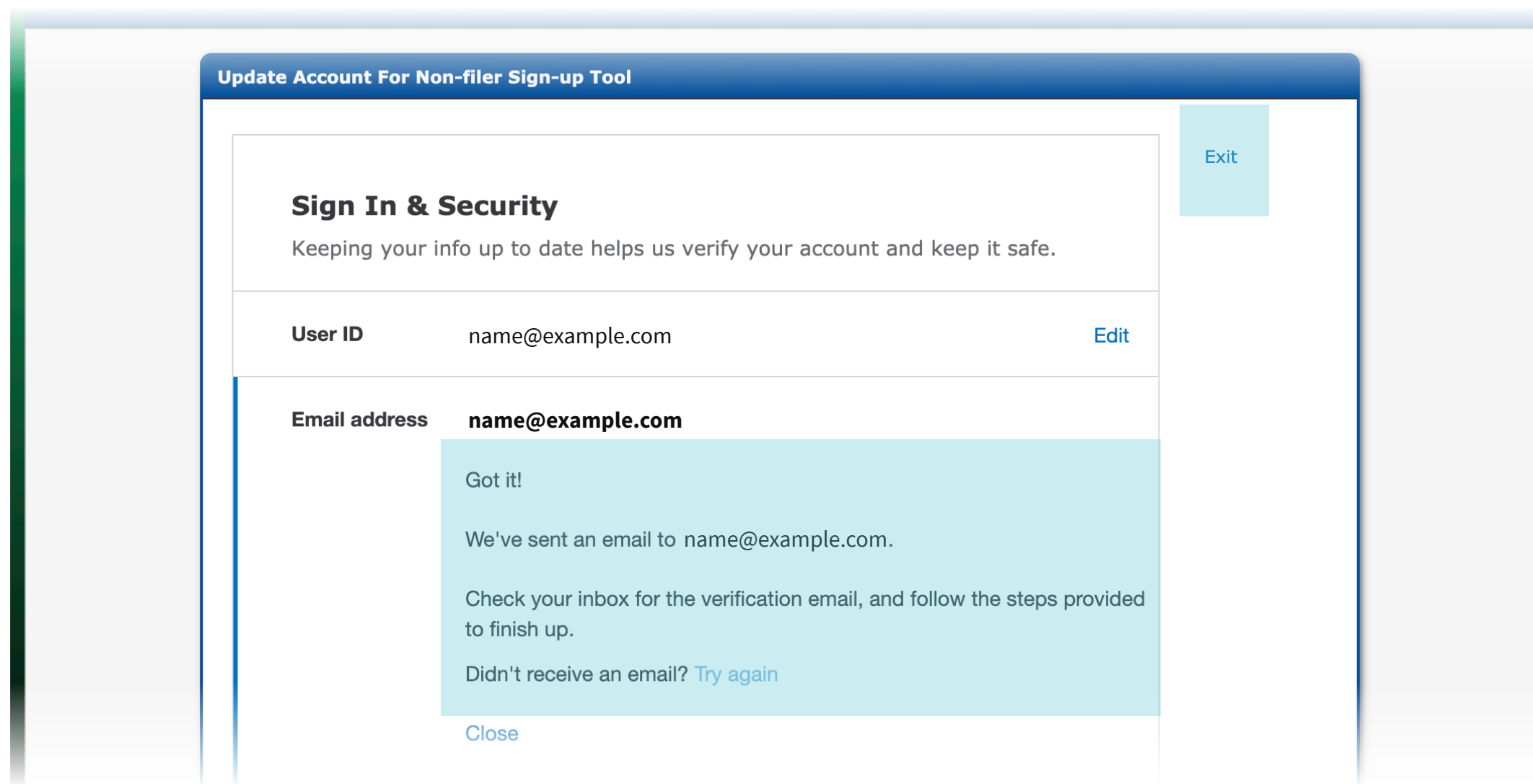



After you submit your form using the Non-filer Sign-up Tool, you can see if your form has been processed with the IRS [Where's My Refund?](#) Portal.\*

After your form has been processed (probably a few weeks after submitting your information with the Non-filer Sign-up Tool), you can check on your tax payments in the **IRS Child Tax Credit Update Portal**. In that Portal, you will also be able to update your bank information and address soon.
